

# How to order Energy Monitoring services from PGE

## Instructions

1. If you have more than five meters, please contact PGE Energy Monitoring services at 503.464.8323 or email EIS@pgn.com
2. Complete and sign the form below.

To find your customer number and premise number, locate your account number in the upper right corner of your PGE bill. The customer number and premise number are included within the account number. **See this example:**
