2018 Tandem Timbers VIP Sweepstakes (the "Sweepstakes")

- Sweepstakes Description / How to Enter:** NO PURCHASE OR PARTICIPATION IN THE SMART THERMOSTAT PROGRAM IS NECESSARY TO ENTER OR WIN. THIS SWEEPSTAKES IS OPEN TO LEGAL RESIDENTS IN OREGON, WHO ARE LOCATED IN PORTLAND GENERAL ELECTRIC'S SERVICE TERRITORY. PARTICIPATION CONSTITUTES PARTICIPANT'S FULL AND UNCONDITIONAL AGREEMENT TO AND ACCEPTANCE OF THESE OFFICIAL RULES. - How to Enter:** You may enter Sweepstake in one of two ways:
- Online:** You will automatically be entered if you successfully enroll in the Smart Thermostat Program on PGE's website.

- Online or mail-in entries must be received by 11:59:59 p.m., PT, September 8, 2018.

- PGE reserves the right to disqualify any person or e-mail address that submits multiple entries. All entries become the exclusive property of PGE and will not be acknowledged or returned. Any submission of robotic, automatic, or programmed entries, or any entries submitted by agencies, other third parties, or through other unapproved methods are void
- Sweepstakes period:** The Sweepstakes runs from 12 a.m. PT on August 1, 2018, until 11:59:59 p.m., PT, September 8, 2018.
- Winner selection:** One winner of the grand prize of a Timbers ultimate fan experience will be selected in a random drawing to be conducted within 7 (seven) business days following September 8, 2018, from all eligible entries received. **Odds of winning depend on the number of eligible entries received.** Winner will

be notified by e-mail message or by phone, within three (3) business days following the drawing date.

10. **Requirements of winner:** Winner of the Timbers tickets may be required to sign and return a release of liability, declaration of eligibility, and where lawful, a publicity consent agreement, within ten (10) days of acknowledged notification. **By accepting and/or using prizes, winner agrees to the use of his/her name, voice and/or likeness for the purpose of advertising, trade, or promotion without further compensation, unless prohibited by law.** If a selected potential winner cannot be contacted, is ineligible, fails to claim the prizes, or fails to return the completed and executed declaration/releases as required within the time prescribed, prizes will be forfeited and an alternate potential winner selected. In the event of a dispute regarding who submitted an online entry, the entry will be deemed submitted by the authorized account holder of the e-mail account. Sponsors reserve the right to request proof that potential winner is the authorized account holder of the email account.

Registered account holders in PGE's service territory may also enter the sweepstakes without enrolling in the smart thermostat program sending in a postcard entry as outlined in the "How to Enter" section, above. Sweepstakes may only be entered from and in eligible jurisdictions. Employees, officers, directors and agents of PGE, its parent companies, affiliates, subsidiaries, advertising, promotion and fulfillment agencies, their immediate family members and persons living in their same household, are not eligible to participate in the Sweepstakes. and conditions of the Sweepstakes. PGE reserves the right to cancel this Sweepstakes at any time without obligation or prior notice. By entering, each participant agrees to be bound by these Official Rules and the decisions of PGE, which shall be final.
