



## **2018 PGE Parks Summer Social Media Sweepstakes Official Rules**

### **1. PRELIMINARY INFORMATION**

Anyone considering submitting an entry to participate in this sweepstakes should read all of the information below for eligibility rules, requirements of participation and an explanation of the prizes. Three winners will be chosen in a random drawing on September 10, 2018.

**PLEASE NOTE: NO PURCHASE NECESSARY TO ENTER OR WIN.** By entering the sweepstakes, participant accepts and agrees to be bound by these rules and by the decision of the Sponsor, which shall be final and binding in all respects. Sponsor reserves the right to disqualify any person or social media post that Sponsor determines to be in violation of any term contained in these Official Rules. Sponsor reserves the right to modify these rules for clarification purposes without materially affecting the terms and conditions of the sweepstakes. Sponsor reserves the right to cancel this sweepstakes at any time without obligation or prior notice. This sweepstakes is open to persons age 18 and over, who are legal residents of the United States and each of whom complies with the additional requirements set forth in these Official Rules. Void where prohibited or restricted by applicable federal or state laws and regulations.

### **2. TO ENTER**

To enter this sweepstakes, visit an official PGE park, take a photo, post it to social media using the hashtag #PGE Parks to submit your picture. Submitted photos will not be accepted or eligible and may be removed from any Facebook, Twitter or Instagram posting associated with Sponsor if, in the sole discretion of Sponsor’s Social Media Manager, they include any content that contains or appears to contain:

- Explicitly profane or obscene material;
- Endorsement (or condones) of illegal drug use, alcohol abuse or other illegal activity;



- Nudity, profanity or extreme or gratuitous violence;
- Any express or implied commercial endorsement;
- Any derogatory characterization of any person or group based on age, race, color, gender, gender identity and expression, sexual orientation, religious beliefs, marital status, mental or physical disability, citizenship, creed, national origin, physical appearance, political affiliation, union membership, or other unethical or unlawful factors; or
- Depictions of any conduct, language or other context deemed inappropriate by the Sponsor.

### **3. ELIGIBILITY CRITERIA**

To enter and to be eligible to receive a prize, participants must meet the following eligibility requirements:

- must be age 18 and over;
- must be a legal resident of the United States;
- must have visited an official park property owned and operated by the sponsor in Oregon and submitted a photo of the park property

Employees of Sponsor, their parent, subsidiary and joint venture companies, as well as members of their immediate families and households (including children and siblings) are not eligible.

Upon selection, winner may be asked to provide proof of age. If at any point during the sweepstakes Sponsor deems an entry ineligible, Sponsor may disqualify that entry and at its sole discretion, select an alternate. You do not need to reside in the



service territory of the sponsor, but need to have visited an official park owned by the sponsor.

#### **4. SELECTION PROCESS**

Sponsor will select a winning entry from random drawing of entries on September 10, 2018, from all eligible entries received. The drawing will have three winners — one grand-prize winner, one second-place winner and one third-place winner will be selected. Odds of winning vary and depend on the number of eligible entries received.

Only one entry per person will be considered in the drawing — multiple entries do not increase odds of winning.

#### **5. PRIZE PACKAGES**

Three winning entries will be selected through a random drawing to receive a prize.

**The grand-prize winner will receive:** One \$150 gift certificate to REI and a free two-night stay at PGE's Promontory Park campground or PGE's Pelton Park campground.

**The second-place winner will receive:** One \$100 gift certificate to REI and a free two-night stay at PGE's Promontory Park campground or PGE's Pelton Park campground.

**The third-place winner will win:** One \$50 gift certificate to REI and a free two-night stay at PGE's Promontory Park campground or PGE's Pelton Park campground.

Camping dates are for the 2019 camping season (May-Sept. 2019) and are dependent upon availability.

Winners are solely responsible for the payment of any and all taxes and/or fees that may be incurred as a result of prizes awarded.

Entries that are incomplete, illegible, postage due or corrupted are void and will not be accepted. If any participant becomes ineligible during the sweepstakes, they may be disqualified.
