Sponsor reserves the right to cancel this sweepstakes at any time without obligation or prior notice. 3. ELIGIBILITY CRITERIA

To enter and to be eligible to receive a prize, participants must meet the following eligibility requirements:

- must be over the age of 18;
- must be a legal resident of the United States;

Employees of Sponsor, their parent, subsidiary and joint venture companies, as well as members of their immediate families and households (including children and siblings) are not eligible.

Upon selection, winner may be asked to provide proof of age. If at any point during the sweepstakes Sponsor deems an entry ineligible, Sponsor may disqualify that entry and at its sole discretion, select an alternate.
